If any vacancy arises in the board of trustees in future, the founder trustee/the managing trustee shall have power to fill the vacancy by new trustees.

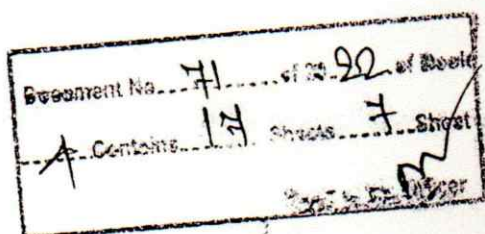

Resolution in writing circulated to all the trustees and consented by majority of them shall be deemed to be the resolution of the board.

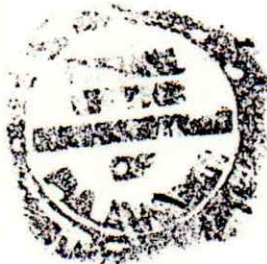
### Alteration of clauses of the trust

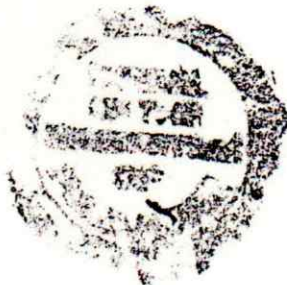

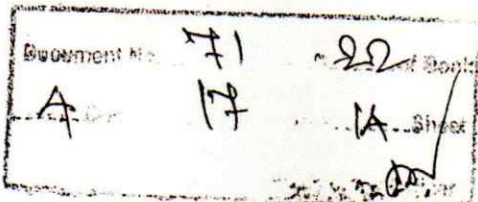

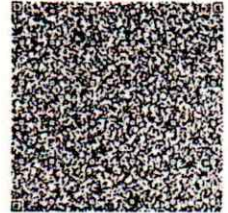
