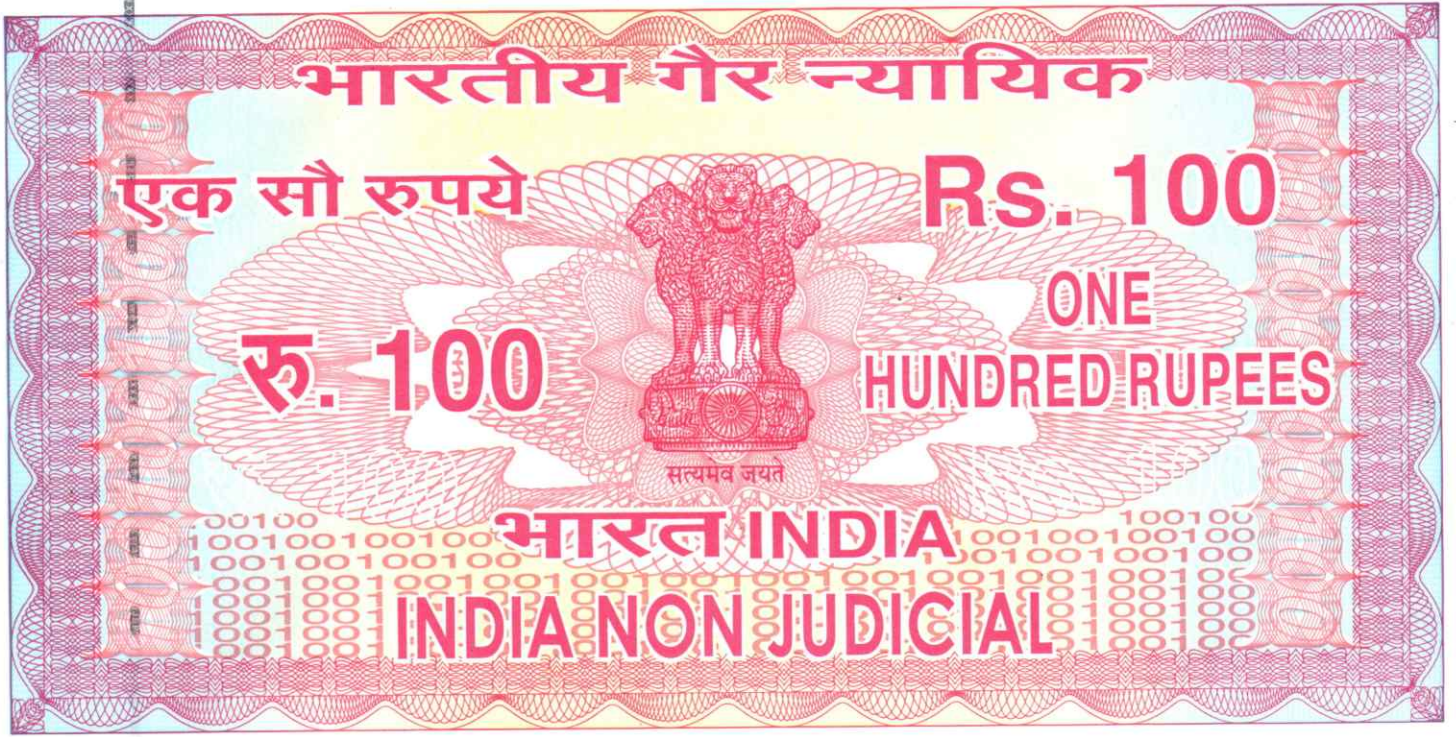
1. That Ramasamyramalakshmiammal educational and charitable trust is a registered trust.
